

## FREE Initial Assessment

Church Planter Profiles integrates the Initial Screening Assessment originally developed by the Emerging Leadership Initiative. This 85 question survey, completed by more than 10,000 potential planters, assesses planter readiness in the areas of:

- Church Planting Experience
- Entrepreneurial Leadership
- Ministry Experience
- Relational Evangelism

The ISA survey is free and must be completed by all potential planters before they may access any of the additional assessment tools. Results are available to the planter immediately online and are also emailed to the agency enabling a quick response to potential planters.

## Analytics

## Cookies

We use data collection tools called "cookies" to facilitate user login sessions. "Cookies" are small files placed on your hard drive which assists us in providing a more efficient and customized experience to you.
